I am aware that skiing/riding is a hazardous sport that includes certain risks and dangers, including the risk of serious injury or death. I voluntarily accept full responsibility for all risk involved, including risks inherent in skiing/riding and the ski area/mountain environment.

I accept my responsibility to ski/ride safely at all times, to abide by "Your Responsibility Code" and to obey all posted behavior notices and any other ski area rules and policies, and the equipment I use while skiing/riding, I use at my own risk. I agree to **RELEASE, HOLD HARMLESS AND INDEMNIFY** Alyeska Resort and any of their employees, agents, contractors, officers, or owners from all claims for any injury or damage resulting from any cause, including negligence, which arises out of my participation in or travel to and from Alyeska Resort. This Release is also binding as to any other persons, including all family members, heirs and executors. If I am signing on behalf of a minor, I recognize that I may not release any claims the minor may have. However, I accept full responsibility from all medical expenses incurred as a result of the minor's participation in or travel to and from Alyeska Resort. I also agree to **HOLD HARMLESS AND INDEMNIFY** Alyeska Resort for any claims brought by the minor(s). This release does not apply to gross negligence or intentional acts.
