**PLEASE READ CAREFULLY – THIS CLAUSE LIMITS OUR LIABILITY.** I understand that the use of a snowboard involves risks of personal injury, property damage and death. I understand that the board/boot/binding system will not ordinarily release during use, nor is it specifically designed to release as the result of forces induced during ordinary operation, and is therefore absolutely no guarantee of my safety. I further agree that I use this rental snowboard ski equipment at my own risk.

**I AGREE THAT** Alyeska Resort, its successors, assigns, officers, agents, and employees **SHALL NOT BE LIABLE** to the undersigned, his family heirs and assigns, for any claims or actions for personal injury, loss, death or damage to the person or property of this undersigned resulting or arising from the rental or use of this equipment, whether or not such injury is caused by the act, omissions or neglect of Alyeska Resort, its officers, agents or employees.

Full Instructions on the use of this equipment have been made clear to me, and I understand the use and function of my equipment; I am aware that Alyeska Resort offers Instruction on the Alaska Ski Safety Act.

For purposes of this release, Alyeska Resort as used herein should include Alyeska Ski Resort, LLC and Alyeska Resort Management Company and their affiliates, parents, directors, agents and employees.
